WHEREAS, the Superintendent received a satisfactory evaluation in the 2017-18 school year; and

WHEREAS, the Parties desire to amend the Agreement in order to extend the Superintendent's term of employment and increase his compensation.

NOW, THEREFORE, the District and Superintendent hereby agree to amend the Agreement as follows:

- 1. <u>Term of Employment</u>. Section 2, *Term of Employment*, of the Agreement is hereby amended to state that the term of the Agreement is from July 1, 2018 through June 30, 2021.
- 2. <u>Compensation</u>. Pursuant to Section 7, *Compensation*, of the Agreement, the Superintendent's annual salary is hereby increased by 1.5%, effective July 1, 2018. Section 7.A of the Agreement is hereby amended to state that the Superintendent's annual salary shall be \$192,850, which shall be paid in twelve (12) approximately equal monthly installments.
- 3. <u>No Other Modification</u>. All other terms set forth in the Agreement and prior amendments shall remain in full force and effect, unless modified by the specific terms of this Second Amendment.
- 4. <u>Entire Agreement</u>. The attached Agreement, subject to the amendments set forth herein, represents the full and complete agreement between the parties.
