WHEREAS, the Governing Board ("Board") of the Coronado Unified School District ("District") adopted a Resolution on March 12, 2020 authorizing and directing the Superintendent, or his designee, to initiate and pursue procedures necessary to not reemploy the equivalent of 1.80 full-time certificated employees of the District pursuant to Education Code sections 44949 and 44955 because of a reduction and discontinuance of particular kinds of services;

WHEREAS, a layoff hearing was convened on April 21, 2020 by the Office of Administrative Hearings for those certificated employees requesting a hearing;

WHEREAS, a Proposed Decision has been submitted by Administrative Law Judge Mary Agnes Matyszewski, Office of Administrative Hearings, in the matter of the District's Reduction in Force of Respondents, a true and correct copy of which is marked "Attachment A," attached hereto, and made a part hereof by this reference; and

WHEREAS, the Board has duly considered said Proposed Decision;

THE BOARD HEREBY FINDS that those matters found in said Proposed Decision do constitute sufficient cause for not reemploying the certificated employees listed on Attachment A and that not reemploying those employees does relate to the welfare of the schools and pupils of the District; and

THE BOARD FURTHER FINDS that said Proposed Decision, including Findings of Fact, Determination of Issues, and Order, should be adopted as the decision of this Board;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the aforesaid Proposed Decision be, and hereby is, adopted as the Decision of the Governing Board of the Coronado Unified School District and said Decision shall be effective immediately;

BE IT FURTHER RESOLVED AND ORDERED that the Superintendent, or his designee, is authorized and directed to notify those certificated employees noted in the Decision, pursuant to Education Code sections 44949 and 44955, that their services will not be required by

the District for the ensuing 2020-2021 school year. Said Notice shall be given by serving upon the employees a true copy of this Resolution.

BE IT FURTHER RESOLVED AND ORDERED that the Superintendent, or his designee, is authorized and directed to take any other actions necessary to effectuate the intent of this Resolution and to finalize the layoff.
